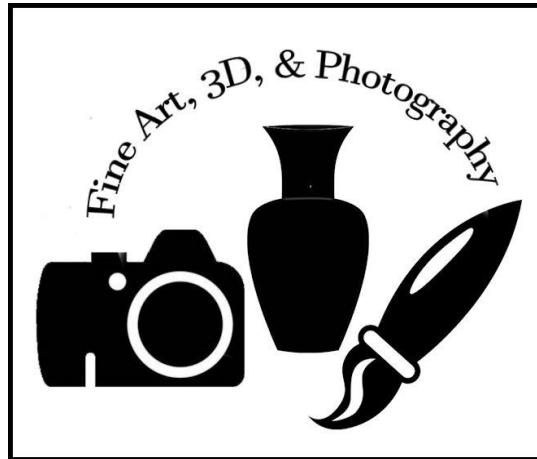

Open Fine Art-Photography-3D**

Fine Art

Fine Art includes Oils, Acrylics, Pen & Pencil, Watercolor, Pastel, and 2 Dimensional Mixed Media. No digital or electronic media will be accepted in FA.

Photography

Photography includes, film, digital and electronic media.

All photography entries will be judged as one in both open and juried.

Three dimensional categories

The art is not flat like two dimensional arts. It is observed in terms of height, width and depth.

Fiber art, wood carvings, leather work, metal, stained glass and sculptures

JURIED ELIGIBILITY

- Entries must be original work, done entirely by the entrant.
- Entries must not be copies, in whole or in part, of photographs by other.
- Works produced in workshops or under supervision are not eligible.
- **Entrants accepted in juried divisions may not submit entries in the same division in the open show.**

CONDITIONS for open & juried

- Awards will be judged from original works.
- Artists may not substitute another work for an accepted work nor withdraw the work once it is accepted.
- **All entries must be for sale. Associated Arts of Ocean Shores receives a 25% commission.**
- All entries must be framed with wire hanger (no clips, no saw-tooth hangers). Gallery wraps are permitted.
- Maximum/Minimum framed dimensions: at least 12" but not to exceed 52" horizontal and/or vertical.
- Entry fees are non-refundable.
- AAOS reserves the right to refuse, upon arrival, any piece of unacceptable quality. Art work that does not match the digital image will not be displayed.
- **Artists are responsible for all shipping costs.**

DIGITAL JURIED ENTRY PROCEDURES

- Jpg format. Maximum size: 4x6" Maximum file size: 1gig
- Save each image as:
"artist's name, division (fine art ,and photography) & title of work .jpg"
e.g., "JaneJames-Photography Still-Life-with-Blue-Vase.jpg"
- Multiple images may be saved to one CD.
- You may submit your image(s) by mail with entry form and entry fee.
- Artwork from emailed images will not be eligible until entry forms and check are received in mail.
- **Digital Entries deadline: March 12th 2018**

Initial Entry Submission Checklist:

- on CD & mailed with entry form/fee or
 - emailed with entry form/fee following
- _____ Entry form completed and signed
- _____ Entry fee enclosed

ACCEPTED WORK

- Work may be hand-delivered or shipped. Instructions will be included in the Acceptance notification.
- There is a \$10 handling fee per artist for shipped works. **(Entrant pays all shipping costs.)**
- Accepted works must be ready to hang, including wire. (Framed or gallery wrapped.)
- CDs of submitted work will not be returned.
- While utmost care will be taken to avoid damage to entries, neither AAOS nor its representatives nor the Convention Center will be responsible for damage to or loss of art works from any cause.

Judging

Accepted work will be judged by recognized judges in each division. Results are not scored and judge's decisions are final. Please check our website for names and judges bio's for the 2018 show.

Juried Entry Fee, Fine Art & Photography

Single entry: \$20
Up to three entries: \$50
Each additional entry: \$10
A maximum five entries per applicant

Open Entry Fee, Fine Art, Photography & 3D

Single entry: \$10
Up to six entries \$50
Additional entries are \$10 each, with a maximum of eight entries.

Open Show Photography Entries

This year our open entries may also include canvas wrap, framed work & metal, not to exceed 16"x20". All entries must be ready to hang. **For Fine Art, see Conditions for open & Juried.**

Pre-registration for the open Show

For your convenience, you may pre-register in the open show by following the same instructions as the juried show entries. However your entry will not require a jury acceptance. You may also mail entry following "shipped work" instructions.

Open show entries do not require prior acceptance review. The open show is for those who consider themselves to be hobbyists or armatures and do not teach or instruct others.
