3. Food Vendors are required to apply for and receive their Temporary Food Permit for the Festival by July 15, 2024 and provide a copy to AAOS by email at artsandcraftsaaos@gmail.com.
4. Vendor agrees to the use of their name, and/or company name and any photos provided, for all AAOS Festival marketing and advertising. Vendor also agrees that videos and photographs taken during the event by Festival staff may be used for promotional purposes during the event and for future events, and are the property of AAOS.
